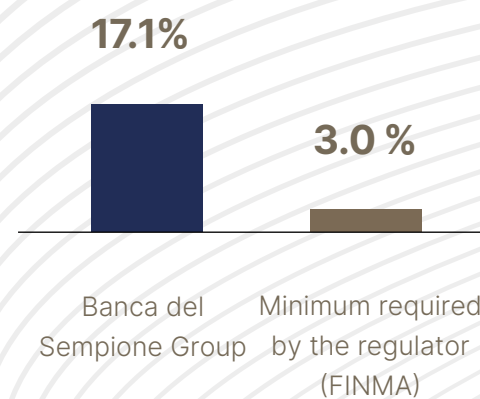

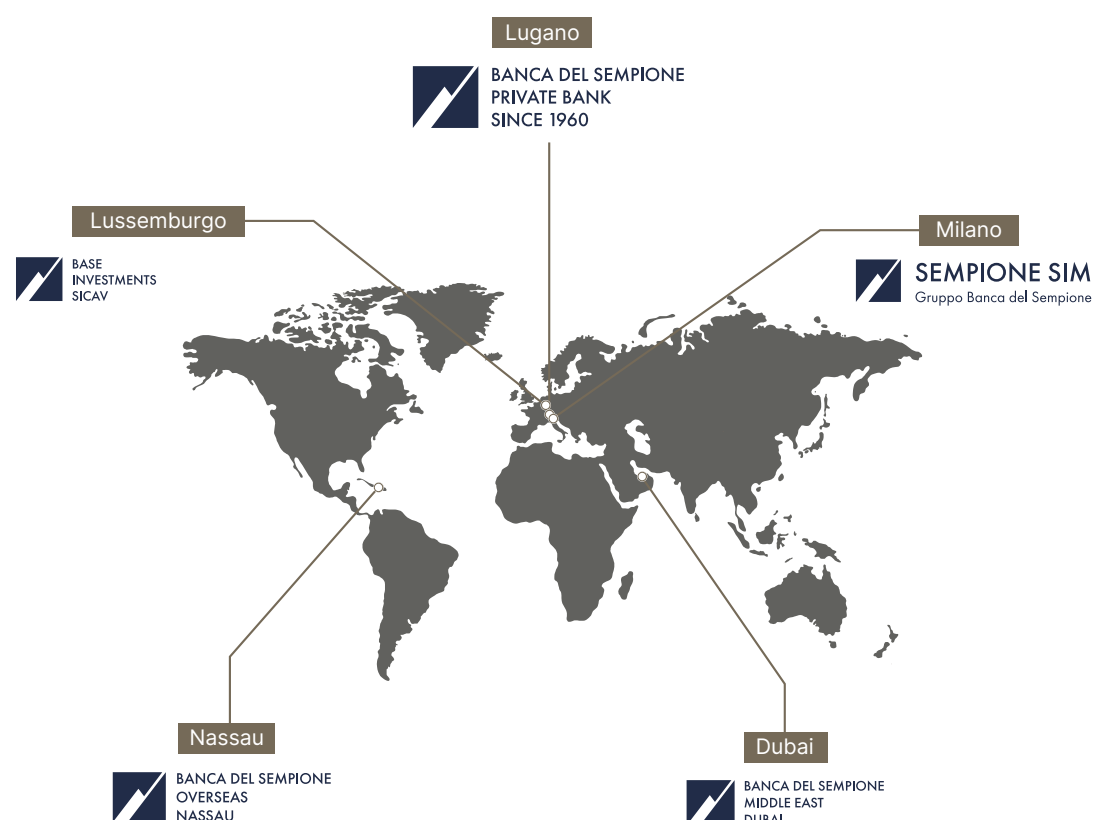




HISTORY

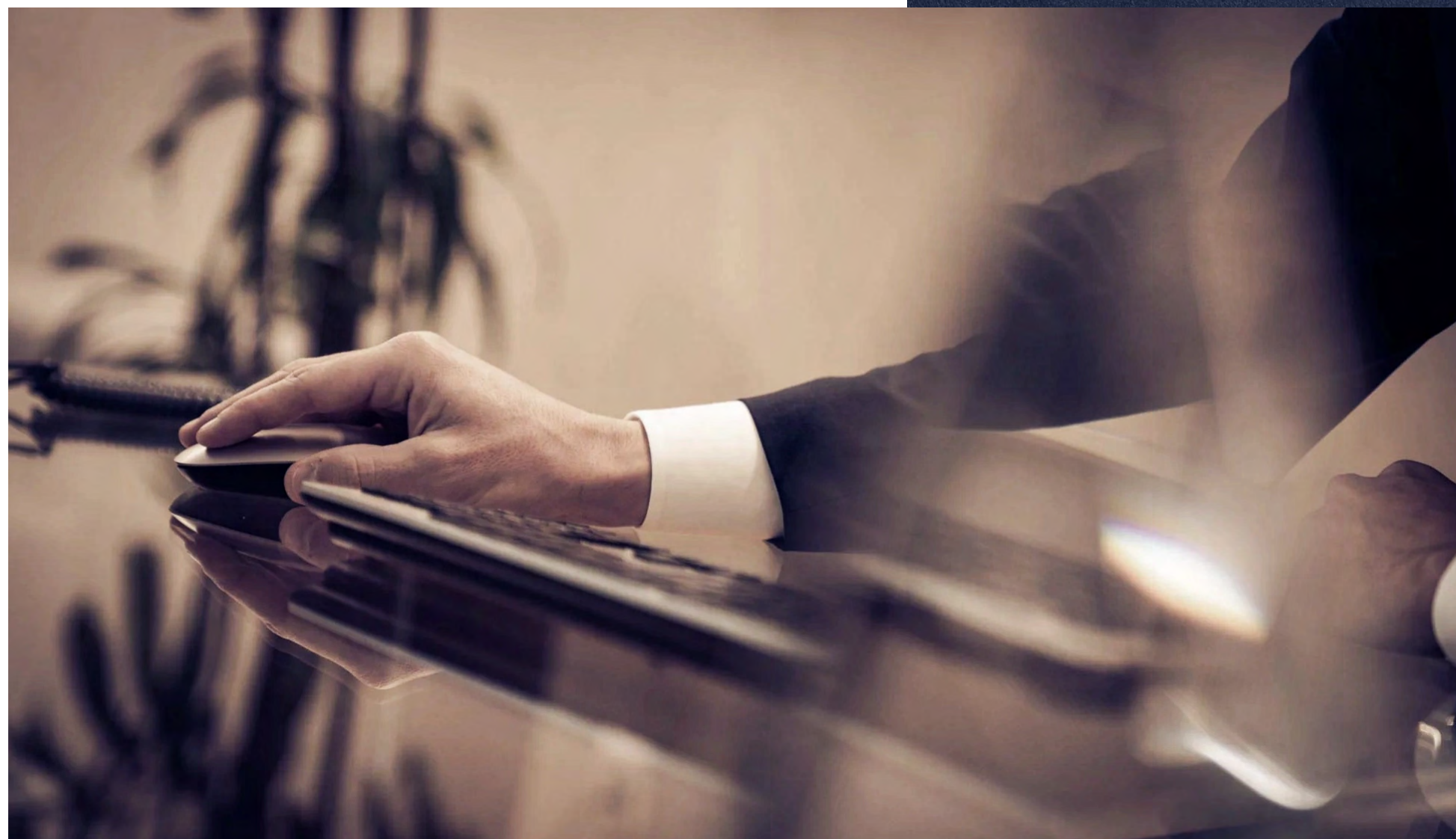
